- Correspondence read out thanking the parish council for the new Sleights Village Trail
- Correspondence read out regarding objection to planning application 22/0607/FL
- Correspondence highlighted that planning application 19/01572/FL on agenda was land adjacent 12 Brook Park and nothing to do with 12 Brook Park itself
- MOP stated that planning application 19/01572/FL land adjacent 12 Brook Park was actually "14 Brook Park" and 12 Brook Park had no involvement in site or development. Concerned that agenda might imply otherwise and wanted the above noted

not seen a resident waiting at the bus stop and had driven by without stopping due to hedge blocking sightline

# 7 REPORT ON MATTERS ARISING FROM PREVIOUS MEETING

The following issues were considered and action decided upon:

- i) Clerk to provide update on NYCC reported issues, if received: Clerk advised as follows
  - a) A169 bridge over River Esk "speed bump" like crossings: Inspector had visited and found satisfactory, but a revisit requested to ensure still to satisfactory standard
  - b) Parking Signs for car park adj Salmon Leap: Additional signage and altering existing sign not a priority, and cannot currently prioritise a site meeting with a project engineer as many other tasks higher priority for the foreseeable future. Following discussion RESOLVED not to pay for any additional signs
  - c) Lighting Pole No 9 A169 covered in vegetation: noted had been passed to local area highways for inspection and if standard defect repair to be within 90 working days d) Signage at A169/Eskdaleside Junction: noted defunct slippery sign, recycle/toilet sign and pole removed. New toilet directional sign in situ with some obscuring by vegetation from a distance; however, resident at Bonnie Banks will monitor situation regarding sign obscuring view when exiting track but currently no issue
  - e) Footpath No 9 Iburndale Sleights tree blockage: no further update but waiting on County Cllr C Pearson feedback
  - f) Change of Speed Limit A169/B1410 junction: already received notification that would be increasing 40mph repeater signs (from Sleights direction). Noted Road Safety Partnership data logged in April of mean speed 32/31 mph and 85th% at 36/37mph and task group identified location suitable for CSW group. RESOLVED to advertise in next newsletter
  - g) Iburndale Lane/A169 junction parking issue: no further updates since advised would be undertaking a consultation regarding introduction of formal parking restrictions in the area.
  - h) Pedestrian crossing, Coach Road: no further updates since advised that recommendation for additional warning signs of pedestrian crossing to be investigated and that existing crossing at refuge island suitable for current use
  - i) Buskey Area, Sleights road flooding: reported but not received further update; however, noted that it had now been dug out and cleaned up
  - j) Birch Avenue Sleights, people not giving way at "chicane"/passing place where parked vehicles, priority signage requested: Clerk had received request for confirmation of location, Cllr AH to obtain photos
  - k) Carrs/Featherbed Lane weed growth, overspill of soil: reported but no further update
  - l) Damaged Sleights Village Sign, Blue Bank: NYCC will be taking new evidence to the contractor and urging them to reconsider earlier response
  - m) A169/B1410 Junction overnight traffic lights: response from County Cllr with highway portfolio that would be investigating

### ii) SBC

- a) 34 Eskdaleside 22/0607/FL proposed new 3 bed dwelling: RESOLVED to Object with the following additional comments:
  - Overdevelopment of site due to topography
  - No reference in plans of ridge height, which should be no higher than No 34 Eskdaleside
  - Inadequate off road parking
  - Verge to House gradient of 21%, and highways requires this to be no more than in in 10, therefore, this is very steep
  - Very little amenity space, and what there is is on a steep slope
  - Drainage channel at the bottom of the slope on the boundary of the site is very important for water draining from Brackenhill Lane and must be kept stable and clear at all times
  - Site drainage must not add to storm water running into above drain, and should not run into above watercourse
  - Concern regarding stability of land and should not impact on the stability of the rest of Eskdaleside roadway
- b) Alderbaran 37 Carr Hill Lane 22/0835/HS erection of 2 storey extension to rear and garage to front
  - a) RESOLVED No Objection to the extension
  - b) RESOLVED To Object to the garage with the following comments:
  - Overdevelopment
  - Industrial style unit in a residential area and will spoil the openness of the area
  - Stability of road a concern and needs a robust means of supporting the road
- c) 12 Brook Park 19/01572/FL to discuss and decide on any action regarding to compliance with condition of 1 in 10 max slope access to garages:

RESOLVED to write to SBC with the following compliance concerns:

- Whilst the ridge height is as the plan, the garage floor to Brook Park ratio is actually a 1 in 3.5
- A 2m high wall has been built in front of the property which was not approved as not on original plan, and appears to have been built to overcome the problem of access to the inbuilt garage
- It is acknowledged that whilst the access exits onto a private road and not a highway the NYCC highway requirement of no more than 1 in 10 may not be enforceable
- There is not sufficient area to park/turn; however, the original plans did not detail this provision

# iii) WOODSMITH PROJECT (AngloAmerican (AA))

- a) To consider any issues in respect of mining activities that impact the parish and decide on actions to be taken: RESOLVED no issues. RESOLVED to investigate option of a site visit.
