#### 7 REPORT ON MATTERS ARISING FROM PREVIOUS MEETING

The following issues were considered and action decided upon:

- i) Clerk to provide update on NYC reported issues:
  - A169 Tree Clearance/Ash Die Back Programme of Works: Clerk read out email from NYC dated 19/6/23, noted still assessing situation and some smaller scale works could still go ahead
  - Ash die back, Briggswath: Clerk reported and under review by NYC
  - Tree on land off Lowdale Lane opp entrance to The Avenue: Clerk read out email from Chief Executive of NYC 7/6/23. Noted response from local operations team that review of trees highlighted OK at present; however, Ash tree presenting evidence of die back and this will be assessed as to whether private or council owned
  - B1410/A169 Grass Cutting Junction: Clerk had reported again issue of lack of visibility following recent incident, awaiting response

- Littlebeck Lane/Dean Hall Brow/Pasturefield Lane failed edging: Clerk reported response stated defects do not meet intervention levels, but road will be monitored during regular safety inspections
- Littlebeck Lane kerbing issue: Clerk not reported as not received photos from Cllr SW
- Top of Carr Hill Lane housing development, mud on road: Clerk reported and to be inspected by highway officer
- Linden Close Wildlife Area: Clerk reported wooden walkway and play park roundabout, response that work in hand. Noted that works not undertaken yet. RESOLVED that Clerk to ask for signage ie "Deep Water" in relation to ditch

# 8 PLANNING MATTERS

The following issues were discussed and decided upon

Cllr DT not present, but had provided a report to be read out by the Clerk

#### i) NYMNPA

- a) NYMNPA Dark Skies Supplementary Planning Document comments by 7 August 2023: RESOLVED to comment: Ridiculous to suggest that no external lighting is fitted to new developments in remote areas. Lighting is required in remote normally unlit areas for emergency, ie storms, or for use during criminal activity events. Lighting should be available but restricted in its use and any lighting should face downwards.
- b) NYM/2023/0276 Underhill Cottage, Bluebank construction of first floor rear extension with balcony: RESOLVED No Objections

#### ii) NYC

- a) ZF23/00885/HS 19 Carr Hill Lane, Briggswath installation of pitched roof to existing garage and extension of driveway: RESOLVED No Objections
- b) ZF23/00728/FL Land Adj to 69 Carr Hill Lane, Briggswath major housing development with landscaping and associated works: RESOLVED to Object with following comments:

Surface water from the site must not be discharged into any of the existing surface water drainage systems to protect properties downstream of the site, consideration being given to an increase flood risk to properties at the bottom of Carr Hill Lane and Briggswath which have a history of flooding issues.

Question the capacity of the Yorkshire Water foul water system in this area and its ability to take an additional 14 dwellings together with the proposed controlled volume of surface water runoff.

Design wise new bungalows are welcome in an area where many bungalows have been lost due to redevelopment.

Request for a condition to be added to limit the height of any future developments of the proposed dwellings.

It is also noted that there is very little space between the proposed dwellings, this is contrary to and not in keeping with the layout of properties in this area. and we consider this new development of 14 dwelling to be an overdevelopment of the site in this area of Sleights.

It is proposed that all 14 dwellings use the same building materials i.e red clay pantile roofs and coursed artificial stone; however, this will give a common estate like look which is seen in many new developments on the edges of villages throughout the country and which effectively isolates the development instead of integrating it. As the development is on the edge of the village, the materials used in the construction of the dwellings should reflect the mixed nature of materials used in the properties in the adjoining area. Therefore, the parish council requests that at least half of the roofs are Grey Slate to break up this bland appearance of the development which is on the edge of the village boundary. Perhaps some of the properties could use brick and some use render finishes to the walls to enhance the look of the estate.

During the construction phase there should be a condition put in place to prevent

contractors' vehicles from parking on Carr Hill Lane and Ridge Lane.

It is noted that the development will also cause an increase of traffic volume on Carr Hill Lane, which is a single track road.

c) ZF23/00639/FL Aislaby View 3 Eskdale Close – construction of steel frame agricultural store building: RESOLVED No Objections but to add a comment that there should be a tree planting scheme to lessen the impact the building will have on the area
