# Introduction

In the summer of 2006 Eskdaleside-cum-Ugglebarnby Parish Council received a communication from the Yorkshire Rural Community Council regarding the availability of funding and support for parishes to complete a Parish Plan.

At the August 2006 Sleights Show an initial consultation was organised with the aims of:

- Raising awareness of the importance of the Parish Planning process
- Providing an opportunity for local people to raise issues of concern to them.
- Encouraging local volunteers to get involved in the development of their Parish Plan.

A steering group, consisting of local volunteers and members of the Parish Council, was then brought together with the task of working over the winter to develop a questionnaire that would meet the aims of:

- Outlining local issues and concerns.
- Identifying local priorities.
- Providing information for the future planning of local facilities and services.
- Providing a robust evidence base to assist funding and grant applications for projects that reflect what local people really want.

Early in the New Year the questionnaire was prepared and coded for analysis before being delivered in March/April to every household in the parish by a bank of local volunteers to whom we are most indebted.

Once the completed questionnaires were returned, the group then embarked on the massive task of data input and analysis, bringing together the 4000+ individual comments spread over the 474 questionnaires returned. We were pleased that 48% of parish households responded. This figure does not take account of the significant number of second homes within the parish that were unoccupied during the time of the survey.

From all the information returned clear patterns began to emerge that have informed the development of the Eskdaleside-cum-Ugglebarnby Action Plan that will set the direction for the parish for the next few years. The group then developed a large-scale version of the plan to feed back the results and allow further comment thus ensuring the outline proposals were what local people wanted to see. The 'big plan' visited the 2007 Sleights Show and then undertook a weeklong stint on display at Sleights Village Hall before a final consultation event was held in late August 2007.

With some minor revision and amendments the content of the plan was ready to be handed to the printers. The help of local volunteers was again called upon to deliver it to the households of Eskdaleside-cum-Ugglebarnby.

We hope you enjoy the results of this year long project and would like to thank everyone who took part in shaping the future of our parish.

Please note that all percentages throughout the publication are rounded to the nearest whole number.

All individual comments are reproduced as expressed and are unattributed.

## A Short History of the Parish of Eskdaleside - cum - Ugglebarnby

Sleights, itself, is not mentioned in the Domesday Book of 1086, but both Eskdaleside and Ugglebarnby are. This Parish has a double-barrelled name because the Parish of All Saints, Ugglebarnby, and that of St. John the Evangelist, Eskdaleside, were united in 1829. This amalgamation lives on in the name of the Parish. The popular name of Sleights has no part in the ecclesiastical history of the village.

From 1086 there are no records of Sleights until 1396, when Sleights is first recorded in the Rolls of Whitby Abbey. At that time Sleights would have been a collection of inferior dwellings. The area at this time was greatly depressed due to the onset of the Black Death between 1370 and 1380.

Thereafter, the area began to repopulate (slowly) with one or two larger houses appearing. Esk Hall is mentioned as Abbey property in 1540, built by Cockerill.

Sleights Hall was built in the 14th century, and it is recorded that the Lord of Ugglebarnby lived there. By 1850, the Hall had fallen into ruin, and was rebuilt as the present building.

The area was first surveyed in 1849 as part of the official Act of 1791 Ordnance Survey of the whole country. In 1853 it shows the area of Ugglebarnby Parish was 2,470 acres and Eskdaleside 1,939 acres. The population at the last census was 1,981. Sleights village is, in the main, excluded from the National Park.

Sleights grew very slowly due to difficult travelling conditions, and people tended to stay put. The most dramatic change came with the coming of the turnpike roads around 1756 and the railway in 1840. This opened up the whole area to travel and trade.

Sleights has had two industries in its past, the first being the Alum industry between 1650 and 1830, with large workings at Littlebeck, Eskdaleside, Hole Bank and Thornhill. This brought a large influx of workers to the area and many rows of cottages were built to accommodate them. This was followed by Iron Stone mining, with smelting works being set up at Grosmont (which was then in our Parish). Again, a great many people were employed, but the industry declined due to better quality iron ore being found in the Cleveland Hills. This decline was complete by the turn of the century when many workers emigrated, and a "W. Morgan" is listed as

being the Emigrating Officer for our Parish. Many sailed from Whitby to such places as Canada. Since then, Sleights has not developed much, with most of the buildings being in-fill. The village remains mainly agricultural, as it was centuries ago.

In 1834 Sleights got its first National school, situated on a piece of land at the junction of Coach Road and Eskdaleside. Henry Walker Yeoman gave this piece of land for "five shillings of lawful English money". The school is now a residential property called "Inkwells".



The present school was built in 1968, and is just off Coach Road at the entrance to Ingham Close.

There is a village pump situated half-way up Coach Road, erected in 1859. Before that, a well, with rope and bucket, was used. The pump was last in use when the great floods of 1930 disrupted the water supply to Sleights. The village stocks stood just behind the pump, although nothing remains of these.

Sleights has two bridges over the Esk: the main road bridge built in 1938 and the footbridge at Briggswath built in 1940. The first bridge at Sleights was built in 1190 for furtherance of trade, a covenant being made between the Abbot Peter of Whitby and Reginald de Rosels, Lord of the land on the west of the Esk. Previous to this, there was only a ford or "wath". This bow bridge was

washed away by flood. It was replaced by a three-arched stone bridge in 1720 – this, too, was washed away by flood.

A temporary bridge followed, with a single carriageway for vehicular traffic with a cantilever footway. This Bridge carried vehicular traffic until 1940 when it became unsafe. All Vehicular traffic was then routed over the main road bridge still in use today.

Sleights has always had its own beacon, but little is known of the original, as there are no visible remains. However, its location is clearly marked on the "Enclosure Map" of 1760. The only description of the beacon says it was on the edge of the moor some 80 chains south west of a bench mark on the church yard corner and close south of the disused quarry above Partridge Nest Farm on Eskdaleside. Eskdaleside-cum-Ugglebarnby Parish Council erected a new beacon on this site to commemorate the Millennium 2000.A.D.

#### Some statistics about responding households.

· 40% have lived in the parish for 20 years or more.

19% have lived in the parish between 1 and 5 years.

The median (average) age is 52 years. This compares with the rest of the UK at 39 years
 –[Office for National Statistics 2006].

 16% feel that they can influence decisions that affect the parish. 43% feel that they have no say in local decision-making. A further 41% were unsure if their opinions were taken into account.

"The nicest place to live, except for 6 weeks I have lived here always".

 "A lovely place to live in. No problems with children. All are very polite and there is never any trouble".

"I live down Iburndale Lane and enjoy the peace & quiet and views over the fields".

### What we dislike about living in Eskdaleside-cum-Ugglebarnby.

Dog fouling

- Anti Social behaviour
- Bonfires/garden fires
- Parking on double yellow lines (especially at the shops and school)

Too little for the young people to do

- · Too much noise, pollution and speeding traffic
- HGV's
- Litter
- Parking on the pavements, especially near the shops
- The cost of living
- Creeping sprawl of housing
- Too many 2<sup>nd</sup> homes/holiday cottages
- Loss of facilities and services

# Some quotes about what people dislike about living in the parish

- "Dog walkers think our area is for their convenience (literally)".
- "The ownership of second homes does concern me as we do now rely on tourism and second homes contribute to that but not to community spirit...in the future the community will suffer".
- "Vandalism. Litter. Dog fouling. Speeding traffic".
- "Being with Scarborough Council, they haven't done a lot for Whitby and district".
- "Need to drive to shopping or leisure activities".
- "Coach Road is like a motorway".
- "Almost all green spaces have gone under horrible housing schemes".
- "Only a few trains run to and from Middlesbrough. A more frequent (and cheaper) service would be good and a more frequent bus service would help".
- "Unfortunately it is easier to complain about teenagers than to try to solve problems. We allow the area to grow, but don't put in place suitable infrastructure to sustain healthy living for all".
- "I dislike the fact that the hair shop has closed but we do have an excellent mobile hairdresser now".



#### Some statistics about respondents:

- 2% do not use the shops or post office, 60% visit the post office and 80% use the shops at least once a week.
- · 25% frequent local public houses once a month or more.
- Local cafes and restaurants are also well used, 25% use them at least once a month.
- The least used facility is the playing field with 77% reporting that they do not use it at all
- 62% of respondents use the garage and petrol station less than once a month.
- · Over 100 households regularly use the village halls at Littlebeck and Sleights.
- The mobile library appears to be well supported with 43% stating that they used it once a month or more.
- Other services that are used often include the recycling facilities and the Bowling Green.

# Church, Chapel and Cemetery



In the 13th century, worship in the parish took place at the Eskdale Chapel the ruins of which can still be seen near the railway line adjacent to the River Esk. This Chapel is known to have existed in 1224 and was certainly used as a regular place of worship by the local residents of Eskdaleside from 1394 to 1764.



St John the Evangelist Church was built in 1894 replacing this earlier Georgian chapel constructed in 1765



St John's features include Grade II listed gates and a peaceful churchyard which has been developed as a haven for plants and wildlife. The church contains a fine carved wood reredos and good stained glass by C.E. Kempe.



The Briggswath and Sleights Methodist Church situated at Briggswath was built in 1905. In November 2000, the Church was flooded by an overflowing blocked culvert and many surrounding properties were badly damaged. The Church re-opened for worship in September 2001 after finding a temporary home at Sleights Village Hall.



Prior to the opening of Littlebeck Methodist church the followers of John Wesley held services in their homes. In 1890 the present church was opened, with a school room being added in 1904.


Most of the interior oak furnishings, including the carving of the Last Supper, are the work of the "gnome" woodcarver Thomas Wittaker.



All Saints Church, Ugglebarnby, was opened in 1872. Occupying what was once the site of a Norman chapel dating from 1137, the present building incorporates stonework from the original church. It is notable for its nave windows which include a rare image of Judas Iscariot



A much later addition to the Parish is English Martyrs Sleights, a Roman Catholic Church, built in 1998 near the site of the temporary building, which had been in use since 1950. Of modern design and construction it is well used and serves a congregation drawn from the Parish and surrounding villages.



#### Other reasons why Church/Chapel important to you:

- Children's groups and monthly family friendly services
- Coffee mornings and jumble sales
- · Churches Together events and activities
- Venue hire for local events and activities
- Local fellowship groups providing support to local people
- Resting place for deceased relatives

The majority of respondents feel that the Church/Chapel is important to their household for a variety of reasons. Only 22% of respondents felt that they were not important to them.

- · A number of you felt the parish needed a full-time vicar.
- More services aimed at involving young people.
- · Praise for 'Churches Together' group.
- The condition of St. John's church grounds and graveyard was a concern to some.

#### Some of your comments on the Church Chapel and Cemetery:


- "Plastic flowers on the graves look awful and nobody clears out the old holly. Xmas wreaths and decorations often remain through the summer".
- "I don't go but hope others use the Church". (house bound aged 87)
- "Are you aware that deer enter the cemetery and eat the buds from wreaths and flowers".
- "Would like to see a Vicar appointed at St Johns ASAP".
- "Churches together is a great development in the area which provides a great vision for the future".
- "Poor parking for the Sunday service".
- "Make more community use of faith buildings & facilities".
- It is lovely that the chapel at Littlebeck is left open for quiet reflection for visitors and residents".
- "Cemetery not available to all families there is a tendency not to accommodate new comers for the first 50 years".
- "As a disabled older person it is too difficult to use, as can only walk short distances".
- Chapel has an excellent group for teenagers between 13-17yrs.
- "Site for a green funeral would be good".
- · "Its shocking outside. Its very untidy".





#### What questions did we ask?

#### Some statistics

- 8% rated Scarborough Borough Council as excellent or good.
- 11% rated the North Yorkshire Police Service as excellent or good.
- 17% rated North Yorkshire County council as excellent or good.
- 28% rated North York Moors Park Authority as excellent or good.
- 40% rate the Parish Council as excellent or good.
- 44% rated the Ambulance Service as excellent or good.
- 45% rate the Fire and Rescue Service as excellent or good.

#### Some statistics about community safety

- 10% of respondents report that they have been victims of crime within the parish in the last three years.
- 44% would like to see more police.
- 17% would like to see better enforcement of the law.
- 8% would like the police to adopt a 'zero tolerance' approach to crime and anti social behaviour.
- 20 respondents report that they do not see any police on patrol.
- 9 respondents report that they have lost faith in the police service.

#### Some of your comments on other emergency services:

- "Very worried about getting to Scarborough in the hour if I have a heart attack or stroke".
- "Response time for all the services are jeopardised in poor weather and at night".
- "We support provision of a minor injuries unit at Whitby Hospital".
- "Ambulance service although very good and helpful when they arrive can often take a long time having to come from far away & have difficulty finding us".
- "Ambulance cover is becoming worrying".
- "Ambulance comes quickly, problem was getting out of Echo Hill due to parked cars on track.
   This is a real issue up here. Also the track is full of holes did not help. Ambulance staff-excellent".
- "We seem to be at the far end of a long line".


#### Some of your many comments on local policing:

- "There is no substitute for a police presence on the streets to build community spirit and responsibility and to deter petty crime and vandalism".
- "Police presence during filming of Heartbeat appears excessive and wasteful".
- "Have not seen a policeman in Briggswath since my burglary last June. Before that it was 4 yrs".
- "Would be nice to see a Police Officer on foot in the village".
- "Nothing is done about cars parking outside shops, speeding or dog fouling, people realise
  that they can do all the above with little likelihood of being caught".
- "Once the control room for emergency calls was moved to Northallerton from Whitby the response time and local knowledge was lost and can't be replaced. This new location can't replace quality of service we had previously".
- "We are lucky to live in an area with such a low crime level".
- "Drug dealing...everyone knows it is happening, so why isn't anything done about it".
- "Since a local Police Officer has been more recently seen around the village, talking to the young people as well as others, I feel crime has been reduced".
- "I feel lucky not to have had to use the police service but poor police presence means that
  petty crime is allowed to flourish".
- "It is nigh on impossible to contact local police. You are put through to a switchboard (Northallerton? Malton?) And just kept waiting".




#### Respondents also report that they are adversely affected by:

- Bonfires
- Motorbikes
- Poor recycling facilities
- Vandalised phone boxes
- Dog owners who discard plastic bags of dog waste everywhere
- Trespassers
- Unattended dogs barking throughout the day and night
- Parking on pavements
- · Gangs of young people
- · Lowdale building development
- Japanese knot weed
- · Discarded farm plastic


#### Areas of environmental concern:

- Dog/horse foul Coach Road/ Selstone Crescent, cricket field, sports field, Linden Close Play Area, School, Birch Avenue, Spar Alleyway/snicket., Iburndale Lane.
- Motorbikes/off road/farm vehicles causing poor conditions Seggymire Lane, Thostle Nest, Littlebeck from A169 main Rd, Tom Bell's Lane, Hagg House Farm. Featherbed Lane. Iburndale Lane. Ugglebarnby footpath. Echo Hill.
- Improved footpaths/road needed at:
   Echo Hill, Path from Church to Throstle Nest, Lowdale to Iburndale, Top of Iburndale Lane, Sleights to Ruswarp.




#### What you told us about local footpaths and bridleways:


- Priority need for a footpath between Ruswarp and Sleights.
- The majority of respondents are satisfied with the condition of the footpaths and bridleways.
- Dog fouling, litter, slurry and muddy conditions underfoot appear to be major issues.
- Featherbed Lane is poorly maintained and very muddy.
- Tom Bell Lane is dangerous, uneven and overgrown.
- Footpaths around Littlebeck and Ugglebarnby have fallen into disrepair.
- Low number of usable bridleways considering location.
- The stiles between Sleights Church and Littlebeck are very difficult to negotiate.
- Concern about motor bikes using and damaging paths and rights of way.
- The bridle path up the side of Eskdaleside is poorly signed in places.
- Footpaths are poorly signed with little upkeep.
- Difficulty getting dogs over stiles.
- Some evidence of denial of access and maintenance of rights of way.




#### Some of your many comments on the local environment:

- "The B1410 between Briggswath & Ruswarp is crying out for a footpath. It is well used by
  joggers, walkers; mums using pushchairs etc but are deadly dangerous because there is no
  footpath and in parts no verge to jump on to. Must there be a fatal accident before something
  is done?"
- "Featherbed Lane is dangerous underfoot due to mud and debris".
- "Station Approach from Briggswath is dangerous underfoot due to weeds, leaves etc".
- "Eskdale Way between Grosmont Farm and Home Farm has sections which could use steps".
- "Ancient trods e.g Featherbed Lane left in bad repair and over grown"
- "Carr Hill to Lambert Hill footpath blocked by bushes, wire, nettles. Echo Hill to Ruswarp footpath impossible around Hagg House farm animal mess, muck, mud etc. Ugglebarnby to Tom Bell Lane muddy/impossible cows and trail bikes. Paths around Littlebeck are very good as forestry commission take more care".
- "To much motorbike damage".
- "No practical footpath on Blue Bank".
- "Footpath along the Carrs should be extended right down to Ruswarp It would also benefit cycle riders to slow down traffic for the whole length not just the built up area"
- "Not enough bridleways open and those that are get muddy and impassable in winter".
- "Bridleways gates need top opening catches that are easily opened on horseback".
- "From Church gates, turn left to the crossing footpath becoming very narrow, please could we have this wider".
- "Its awful...when you take your children to school and there is too much dog dirt on the footpaths or on local bridleways".
- "The public footpath outside my house is only about 12' wide and it is dangerous to use in view of fast continuous traffic".







#### Some statistics about conservation and wildlife:

- 78% of you said you would like to see local schemes to encourage and protect wildlife.
- Of the people who offered more information on conservation and wildlife, they said we should aim to encourage and protect:
- Hedgerows, verges, trees, bushes and field edge strips (23%)
- · Birds, including owls (11%)
- Badgers (3%)
- Bats (3%)
- Hedgehogs, Red Squirrels and Foxes (3%)
- Frogs and Newts (2%)

# Ideas put forward to support the natural environment included:

- · Planting more trees, bushes and shrubs in the parish
- Reducing hedge and grass cutting to encourage wildlife
- Clearing overgrowth
- Putting up more bird boxes
- Wildlife information signs to provide information and raise awareness of local species
- Encouraging the reduction of chemical weed control
- Developing a local reporting scheme to register frogs, birds and other rare and endangered species
- Restricting hunting
- Banning off road vehicles in the national park
- Reintroducing a village pond/duck pond
- · Reintroducing wildflower meadows

# Access to Health Services





#### What Questions did we ask?

#### Some statistics:


- Over 95% of people responding feel they can access a doctor when needed although a significant number of people raised concerns about the availability of a doctor outside normal practice hours.
- Almost 40% of people responding have difficulty accessing a dentist.
- The majority (33%) of people who told us about accessing their health visitor said they could access the service when needed. 7.5% said they could not access the service or could only access the service sometimes.
- 34 people said they could access the baby clinic when needed. However, 9 people said that
  they could not access a baby clinic or could only access the service sometimes.
- 59 people who responded to the question about home care said they could access the service.9 people said they could not access the service. Another 9 people said they could only access the service sometimes.
- 264 people (64%) feel they can access the hospital services they need.
- 49 people (12%) feel they cannot access the hospital services they need.
- 54 people (13%) said they could only access the hospital services they need sometimes.
- Chiropody and opticians were noted as other health services that people had difficulty in accessing.
- . The need for better transport links to and from health services was also raised as an issue.

#### Your suggestions for improving local health:

- 47% say we should improve and protect hospital services at Whitby.
- 23% say more health services should be delivered locally.
- 13% suggest we need more advice and support to develop healthy living.
- 11% feel that we need more drug advice and support.
- 6% say that we need more help and support to stop smoking.






# Housing

- We also asked if you knew where to get grants and advice from to keep your home adequately warm in winter.






#### Some statistics about housing:

- 88% of respondents are owner-occupiers.
- 9% of respondents rent their home from a registered social landlord such as Yorkshire Coast Homes,
- 2% of respondents privately rent their home.
- 1% say their homes are provided by their employer.
- 1 in 5 of respondents report that they have known at least one person who has had to leave the parish due to a lack of affordable housing.
- 55 respondents say that a member of their household would directly benefit from the availability of affordable housing in the next 5 years.
- 78% of respondents are in favour of a small affordable housing development if there was a proven need.
- 23% of households that would benefit from locally available affordable housing in the next five years have adult children living at home.
- 11% of people who would also benefit from affordable housing have children who will be aged over 18 in the next five years.
- 78% of respondents think new building in the parish should be restricted
- Less than half (47%) of respondents know where to get help and advice to keep their home adequately warm in winter.

- We also asked that if the running costs of a car were met, if you or a member of your household would be interested in becoming a volunteer community car driver to help local people attend hospital etc.























#### Some statistics about respondents:

- 63% think speeding traffic is a problem or major problem.
- 52% think that Heavy Good Vehicles (HGV'S) are not a problem.
- 28% think HGV'S are a problem or major problem.
- 20% Think HGV'S are a slight problem.
- 70% think that road traffic accidents are either not a problem or a slight problem.
- 70% are adversely affected by on street parking.
- 57% are adversely affected by the lack of off street parking.
- Drivers parking on pavements adversely affect 65%.
- 75% report problems with inconsiderate drivers.
- Over half (56%) report no problems with noise from traffic.
- 20% report traffic fumes as a problem or a major problem.
- 29% think traffic congestion at peak times is a problem or major problem.
- 14% report that they have particular transport needs due to having a disability or young children.
- 53 (11%) households have no access to a car or van.
- 28% would make use of a local transport scheme to attend hospital or other medical appointments.
- 29% would make use of a local transport scheme to go shopping.
- 14 households would make use of a transport scheme to access childcare or after school activities.
- 68 households would make use of a transport scheme to access leisure facilities such as cinema or sports centre.
- 30 households would make use of a scheme to travel to work.
- If referred for hospital treatment, 110 households say they have the transport they need only sometimes, 29 respondents state that they never have the transport they need.
- If the running costs of a car were met, 59 households say they would consider becoming a
  volunteer driver to help local people access hospital appointments etc.
- 80% are unaware of the Wheels to Work Scheme that provides the loan of a moped and the necessary training to help people access work and education.
- 63% are unaware of the Coastal Car Scheme, which provides volunteer transport for older people and people with disabilities to access hospital, shopping and hairdressers etc.






#### Some of your many comments on traffic and transport:

- Suggest 40 mph restriction from A171/A169 roundabout to the top junction with Carr Hill Lane. 30 mph from there.
- The junction of the A169 with the Ruswarp road is unsafe when trying to join A169 opposite Woodland Drive due to fast traffic.
- Make parents walk kids to school.
- · Weight restriction on lorries using the Carrs to Ruswarp make them use top road.
- Small roundabout where the B1214 meets A169, turning right from B1410 is big problem, maybe it would also help to deter speeding down A169 from roundabout.
- Take away bollards on the Carrs, they do not stop speeding only cause bumps.
- Something to stop people using Birch Ave as a short cut. There are so many children who
  play out on the streets; surely it would be common sense to stay away from these areas
  unless it was for access.
- 'Road not suitable for heavy traffic' signs on all roads through Ugglebarnby.
- Birch Avenue should have speed bumps to reduce boy racers.
- Enforcement of current measures parking outside Spar shop & Radfords butchers on yellow lines and zig-zag area of pedestrian crossing as well as speeding cars and motor cycles along Birch Ave.

# Children and Young People

The Parish Council accepts that there is a lack of local facilities for our children and young people and has in the past taken steps to locate land for this use. Due to objections from adjoining properties and other barriers, we have thus far been unable to locate and develop a muchneeded resource for our children and young people. To address these issues the parish council will:

- Take steps to promote and publicise the range of opportunities and activities available to children and young people via the Parish Newsletter.
- Endeavour to bring together a group of local children and young people, their parents and others with agencies to improve local activities and opportunities by supporting the development of a Children and Young People's strategy for the parish.
- Work with Youth Service to explore and report options to improve access to facilities and services available outside the parish.

# Monitoring and Evaluation of the Parish Plan

The responsibility for the monitoring of the Action Plan lies with the Eskdaleside-cum-Ugglebarnby Parish Council which will carry out ongoing monitoring throughout the life of the Plan including developing appropriate reporting and feedback structures for any working or action group it may convene.

Each year the Parish Council will take steps to inform and update local people of the performance of the Plan. Additionally, it will form a key part of the Annual Parish meeting to enable local people to give their views and make recommendations.

The Parish council will commission a mid-term evaluation of the Plan at the end of 2010 and will report this to the wider community. It is also intended that following monitoring and/or evaluation, the Parish council will consider the need to revise the Plan and may decide to embark on a partial or complete review of the Plan at any point.

The results of monitoring and evaluation will be publicly reported.
