i) **NYMNPA**
a) NYM/2023/0386 – 42 Iburndale Lane, Sleights – non material amendment to planning approval NYM/2021/0545/FL to allow alterations to design of approved single storey rear extension – Noted unable to respond due to 10 day deadline from 7/7/23
b) NYM/2023/0490 1 Eskdaleside Sleights – application for change of use and subdivision of guesthouse together with alterations to create 2 dwellings with associated amenity spaces, bin store, shed and boundary treatments: RESOLVED No Objection

c) NYM/2023/0446 – creation of 8 wildlife ponds at Esk Valley, 1 pond at East Barnby at land located south and west of Whinstone Cottage, Esk Valley & located NW of Barnby Sleights Farm: RESOLVED No Comment

d) Blue Bank Car Park – Motorhome Parking: to discuss and feedback on NYMNPAs tentative proposal to formalise 8 spaces for motorhomes at Blue Bank car park before proceeding to planning application: Following discussion RESOLVED No initial objection to proposal subject to following: what level of warden supervision, ie not worth risk of non compliance by users, and should be stated in planning application minimum standard of attendance; in planning application caveat that if abused then the trial can be stopped and revert to current status; fee should be no less than £10; need to specify penalties for non compliance

d) ZF23/01283/FL Lowdale Court Sleights – change of use of residential garage to beauty salon: RESOLVED Object with comment that unsuitable location for business as in a residential area, and there is no off street parking with the access lane not being adequate

e) ZF23/01284/HS – 11 Birch Avenue Sleights – erection of shed in front garden: RESOLVED No Objections

f) 22/02025/HS 1 Orchard Road Sleights – roof balcony to front elevation: RESOLVED Object with comment that overlooks and has unimpeded views to adjacent properties hence impacting their level of privacy

1. Public Conveniences, Eskdaleside (VJP)

a) To receive information on any maintenance or other issues and decide further action if required: Clerk advised ladies sink had been blocked but cleaner had cleared

b) Blockage of Ladies toilet – to receive update on works authorised to be undertaken: Clerk advised waiting on dates for September from contractor.

c) Gents sink tap flow issue – Clerk authorised replacement insert – total cost £73.09, Cllr DT fitted and all now working

d) To receive information and quotes regarding potential self employed contract cleaner: RESOLVED to contract Rachel Stuart at quote of £17 per hour VJP

RESOLVED for Clerk to ask S4W to move, with S4W to liaise with CllrDT in first instance in order to undertake some renovation work VJP/DT

- Noted that Featherbed Lane completed, Clerk already thanked the team, RESOLVED to ask if there will be regular maintenance of this lower stretch VJP

- Briars onto footpath before The Avenue

ii) To receive update from NYMNP on PC's Priority Route" proposal, if received: Clerk advised no report received

4. NYC/Highways Issues to consider and decide any further actions required:

i) To note as individuals, Cllrs can raise issues direct with NYCC Highways without having to go through the parish council or the Clerk - but cannot act or make decisions on behalf of the parish council: Noted

ii) NYCC sent various details of road work notifications: Noted

iii) Littlebeck Bank - waterflowing down road: request by Cllr SW to discuss – to decide further action: RESOLVED to ask if can survey the area and identify a long term solution to this ongoing problem to stop/divert the water/streams coming from the adjacent landfill site, which has caused the road to move/sink VJP

iv) Sleights Car Park (centre village): request by Cllr DT to discuss getting a time limit on parking and to decide further action: RESOLVED to ask if a 2 hour time limit disc zone could be initiated with delineated spaces and traffic warden to monitor VJP

v) Linden Close Flooding issues: request by Cllr MW to discuss what further actions if any the parish council can take to help alleviate this issue, and to decide how to proceed: RESOLVED to ask NYC to review situation due to recent blocked culvert in heavy rainfall that led to flooding of nearby garages VJP

vi) To receive highway issues from Cllrs and to decide if any action to take. RESOLVED to report the following issues: VJP

a) From A171 direction, A169 40mph signs invisible due to trees overhanging and sap covering signage, and request lighting

b) Pasture Lane to Iburndale: potholes and deep verge edge drops need filling

c) A169 Bridge over River Esk SW corner getting worse with cyclist observed nearly knocked over due to car swerving to avoid dip in road with camber pulling the vehicle in

d) Littlebeck Lane/Dean Hall Road junction to hamlet needs resurfacing

e) Blue Bank, Sleights- emergency run off needs maintenance as full of weeds and litter

f) Linden Close/Carr Hill Lane junction, Briggswath: joining brick area requires tarmac removal following recent resurfacing works

g) Carr Hill Lane, Briggswath resurfacing: poor standard of workmanship, can this be reviewed as there is a step between the old/new tarmac

h) Linden Close, Briggswath – noted grey water during resurfacing works would have flowed into River Esk

i) 28 Birch Avenue, Sleights – hedge overgrowing pavement

j) Birch Avenue, Sleights passing layby continues to be parked in, no enforcement of restrictions – can long term solution be considered

k) Lowdale Lane/Coach Road junction, Sleights – parking on both sides of the

road causing obstruction to vehicles wanting to travel down Lowdale Lane – can long term solution be considered

5. Coronation HRH King Charles III – to consider and decide on following:

a) Hornbeam– on hold until new financial year, and to plant tree in Autumn 2023, note VJP
licence application submitted and waiting for confirmation: Clerk updated to advise
licence for tree approved and in place

b) Hornbeam Plaque – design/wording on hold until tree planted.

i) to receive update on manufacture of seat: Clerk reported now made and
awaiting installation VJP
